



## New Ordinary Academicians - New Board of Directors Statement by Abp. Paglia and Msgr. Pegoraro



Vatican City, Oct. 15, 2022. The appointment of the new Ordinary Academicians represents an important event for the entire Pontifical Academy for Life. Our commitment deepens, following the guidelines indicated by Pope Francis in the speeches he has addressed to the Pontifical Academy for Life in recent years and in the definition of the 'strategic' objectives of work and study, contained in the 2019 Letter *Humana Communitas*.
